

**FALCON DOOR & WINDOW, INC.**

**Aluminum Storm Door Warranty**

Effective date: January 2007

LIMITED WARRANTY

**STORM DOOR UNIT**

The Falcon Storm Doors installed on the premises at the address specified in this Warranty Certificate are warranted by the Manufacturer, Falcon Door & Window, for a period of 10 years from date of purchase to the Original Owner of Owner-Occupied Residential Property against any defects in material and workmanship occurring as a direct result of the manufacturing process, as to the structural parts and the mechanical components of the storm door unit, under normal use and service, subject to the terms and conditions contained in this Warranty Certificate.

**GENERAL PROVISIONS**

Any claims for defects under this Warranty should be submitted in writing to the Manufacturer, Falcon Door & Window, P.O. Box 149 Malden, MO 63863, Attention: Warranty Claims, promptly after discovery, describing the defect claimed, photographs of affected area, and written proof of purchase. Allow a reasonable time for inspection purposes. If after inspection by Falcon Door & Window, it is determined that the claim is valid in accordance with the provisions of this Warranty, Falcon Door & Window agrees at its option to repair or replace any defective part or component without charge which shall be shipped to Falcon Door & Window with transportation charges prepaid. Falcon Door & Window will pay transportation charges back to the Property Owner's premises.

The original warranty period shall not be extended by any such repair or replacement but the remaining Warranty time period shall continue to be in effect and be applicable under the terms and conditions of this Warranty to the repaired or replaced part or component of the door.

Falcon Door & Window reserves the right to discontinue or change any Falcon Storm Door as manufactured. If the part or component of the door originally installed is not available and Falcon Door & Window determines to make replacement, Falcon Door & Window shall have the right to substitute such part of component designated by Falcon Door & Window to be of equal quality and price.

This Warranty only covers manufacturing defects as specified herein and does not include defects or damages attributable to: installation, normal weathering or defects or damages caused by riot, or civil disorder, misuse, abuse, or harmful fumes, vapors or accidents, or fire, flood, wind or other Acts of God, or by vandalism, chemical pollutants in the atmosphere, mildew, building settlement or structural failure of walls or foundations, or if subjected to stresses resulting from localized heat which causes excessive temperature differentials over the glass surfaces or edges, or water damage due to lack of sufficient structural overhang or water diversion, or any other causes or any occurrences beyond Falcon Door & Window's control. Condensation on windows which may occur as a natural result of humidity within the

house or building area, and interior/exterior temperature differentials does not indicate a defect in the door and would not be included in this Warranty. This Warranty is valid only if genuine Falcon Doors manufactured by Falcon Door & Window are used; but shall be void if door has been modified and/or any accessory products not manufactured by Falcon Door & Window are installed which causes defects to occur in the doors.

All Hardware sets and parts thereof; all Handle sets and parts thereof, are warranted for a period of one year from time of purchase.

This Warranty shall be for the benefit of the original Property Owner within the stated Warranty periods, and is limited to material costs of repair or replacement for defective parts or components and return transportation costs, as provided and does not include labor cost or reinstallation fees, damaged or broken glass or plexiglass or screening.

THE WARRANTY STATEMENTS CONTAINED IN THIS CERTIFICATE SET FORTH THE ONLY EXPRESS WARRANTIES EXTENDED BY FALCON DOOR & WINDOW FOR THE DOORS, AND THE PROVISIONS HEREOF SHALL CONSTITUTE THE PROPERTY OWNER'S EXCLUSIVE REMEDY FOR BREACH OF THE WARRANTY GIVEN UNDER THIS CERTIFICATE. ANY IMPLIED WARRANTIES IMPOSED BY LAW, SUCH AS THE IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE ARE LIMITED IN TIME TO THE EXPRESS DURATION OF THIS WARRANTY.

FALCON DOOR & WINDOW, INC. SHALL NOT BE LIABLE TO THE PROPERTY OWNER FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES FOR BREACH OF ANY WRITTEN OR IMPLIED WARRANTY ON THE STORM DOORS.

Some states do not allow limitations on how long an implied warranty lasts, and some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusions may not apply to you. This Warranty gives you specific legal rights, and you may also have other rights which vary from state to state. The laws of Missouri shall apply regarding the terms and interpretation of this Warranty.

This Warranty may be validated by completing the Registration Certificate signed by the original Purchaser-Property Owner and mailed to Falcon Door & Window within thirty (30) days of the purchase.
